#### 17.82 Minutes

Minutes of the Parish Council meeting held on 19 October had been previously circulated and were **APPROVED** as a true and accurate record.

## 17.83 County Councillor Report:

County Councillor Roger Huxstep advised the Council of his appointment as WCC representative for Droxford on the SDNPA. His emailed report was to follow

HCC's response to DCLG 'Planning for the right homes in the right places' consultation called for cash for county wide strategic infrastructure to support housing growth and unlock economic potential. Government support to enlarge the green belt is sought to protect strategic gaps and mitigate impact of development.

Highways – M27 Junction 9 improvements – exhibition.

Education - Hampshire school children outperform pupils in similar counties. 90% of schools are rated as good or outstanding. The cost of a school lunch has been increased by 15 pence for all school children.

Social Services – those at risk are being encouraged to go for a flu jab.

Councillor Melson asked if HCC had decided the future of school crossing attendants. Councillor Huxstep said that there are 200+ across the county at a cost of £6000 each. HCC is looking at ways of keeping them on.

Adoption of the sewer pipe by Southern Water and connection to the treatment plant in Chestnut Rise has been approved.

## 17.86 Recreation Ground, Cemetery and Allotments:

## 17.86.1 Recreation Ground Play Project:

Councillor Melson said that the Scarecrow Bonfire and Fireworks had been a very successful event enjoyed by a large number of the community. She wished particularly to record the Council's appreciation of the immense contribution made by Barbara and Michael Chandler, Chris Horn, Rosie and Tony Hoile, Tim and Lynn Dumbrell, and numerous others. She observed that if it is to be an annual event, more volunteers would be needed as Parish Councillors could not be expected to organise all that was entailed in the event and clear-up.

Car parking at the Recreation Ground:

Councillor Horn said the tractor-driver had difficulty accessing fields due to parked cars obstructing entrance to the lane. Councillor Dennington reported the newly extended car park was half empty while cars continued to be left outside the Montessori and Droxford Junior School.

#### 17.87 Roads, Transport and Highways

#### 17.87.1 Matters arising:

Drainage line across the Manor Field to the River Meon: The Council is to contact the landowner, HGV signage A32 / Swanmore Road: No further action until there is sufficient evidence to take to Highways.

Ash tree over hanging B2150: SDNP tree officer had identified and contacted the correct landowner.

17.87.2 Lengthsmen highways related tasks w/c 20 November:

Councillor Dennington raised a point concerning the increased volume of large HGV vehicles on the A32, particularly Veolia. Vehicles should be routed via the M3 or A3 in most instances. Councillor Melson undertook to write to the transport manager to ask why movements have increased.

#### 17.88 Footpaths & ROW

17.88.1 Members of the Council had walked the routes across FP17 and FP12 and considered the existing stiles which are all located where livestock are kept.

The Council unanimously **AGREED** to replace stiles with kissing gates in principle and to seek the relevant landowners' permissions. However some members continued to express reservations about galvanised metal used in recent Countryside Service installations. There was some objection to the size of the new kissing gates compared to existing kissing gates (e.g. the black iron gate exiting the Churchyard to FP 17). Timber kissing gates or painted metal are the preferred option but It was noted that galvanised metal gates can be obtained free of charge from the Countryside Service. Any gate specified as part of a grant application must comply with Countryside Access minimum widths to enable disabled access. The Clerk was asked to look into the cost of a timber kissing gate.
