## 19.56 Apologies for absence.

# 19.60 Public Forum:

No members of the public were present.

19.60.1 County Councillor Roger Huxstep reported -

'<u>Vision for Hampshire 2050'</u> is the conclusion of the Commission of Inquiry unanimously adopted by HCC. Expert opinion was sought to look at emerging trends due to the effect of digitalisation and climate change to help shape future policy. See <a href="www.hants.gov.uk">www.hants.gov.uk</a> for Hampshire 2050.

<u>Library Funding</u> will be subject to significant budget cuts which will involve closures, reduction of opening hours or relocation. Proposals will be drawn up for public consultation.

<u>Vaccinations.</u> A reminder from Public Health England (PHE) to defined age groups to arrange vaccinations for protection against MMR, the 4-in-one booster for diphtheria, tetanus, whooping cough and polio. Over 65s and carers of those at risk should be vaccinated for influenza.

19.60.2 District Councillor Frank Pearson reported that the volume of continental lorries from Portsmouth via Swanmore Road, Droxford to Hill Orchard Farm (Axtons) is under debate at WCC. His report covers in more detail -

<u>Citizen assemblies and 'Called Forums'</u>. The former applies mostly to the city, the latter to the large sites at North Whiteley, Kings Barton and Newlands.

<u>Waste Collection</u> . Kerbside bottle collection has started but Hambledon, Swanmore, and Bishop's Waltham bottle banks remain open.

 $\underline{\text{Kerbside kitchen waste collection}} \text{ is still being costed. The drawback is lack of facilities to treat in Hampshire.}$ 

<u>Unforeseen Levy</u>. Project Integra has been scrapped. WCC has received a local authority fine of £500,000 for contaminated dry recyclables. This will be a major budget problem

which may entail a 3% increase in the City portion of the Precept; free car parking to be dropped in certain postcodes and a charge for garden waste.

Cllr Weston had previously circulated her report but added WCC had introduced a new preapplication service.

b) External Auditor's Report and Certificate.

In response to Cllr Matthissen's query, PKF Littlejohn asserted inadequate information had been provided which was that £14,000 of £14,999 was predominantly a single payment to one supplier. The Clerk had not seen PKF Littlejohn's request to account for £999 in detail. Nonetheless the external auditor's opinion was that the 2018/19 audit return was in accordance with proper practices and no other matters had come to their attention to give concern arising from legislative matters.

District Councillor Pearson reported an update had not been provided. He will pursue.

19.62.4 Community Infrastructure Levy (CIL):

Members of the Council met with the SDNP Projects Planning Lead on 16 October to discuss where accrued CIL funds could be optimised. The Parish Council holds £4798 for Open Space. SDNP holds Transport Contributions arising from developments at Townsend and Clementine Cottage totalling £39,109. The Council was advised to prepare costed plans for open space and infrastructure projects ready to submit to SDNP when funds are available for release. Schemes —to be considered for transport contributions will include re-surfacing of the Square and road safety measures elsewhere. Open Space funds could be applied to the Parish Green. It was noted that any Highways

#### 19.63 Recreation Ground, Cemetery and Allotments:

19.63.1 The Pavilion: Matters arising.

Cllr Dennington reported the first phase of refurbishment had been completed for less than £50 over budget. Payment in full of the Contractors invoice for £24,750 plus VAT was recommended and approved. Savings were achieved by installing insulated ceiling panels instead of insulating the roof space, balanced by additional spend on £1318 to create the new door opening and £1480 to remove asbestos. Phase 2 will include installation of a kitchen, a disability access concrete ramp beneath the new door opening and boxed seating to store sports equipment. A floor covering will be required suitable to withstand use by cricketers' footwear. A target date for full completion has been set for 1 April 2019, further details will be provided at the November meeting.

19.63.2 Cemetery: Matters arising:

- a) Removal of shed: Postponed. The contractor advised against churning up wet ground with the tractor.
- b) Badgers digging around graves the application process for a licence to move a badger sett has been started.
- b) Tree surgeons crown lifted sycamores overhanging the southern side of the grassed area and trees on the north and western boundary. The dead ornamental tree next to the beech hedge was felled.

19.63.3 Allotments:

19.63.3.1 Revised Agreement and Terms & Conditions of Rent. The final draft had been circulated. Significant changes are a request for a deposit, a ten year tenancy with a 1 month notice period either way, and a ban on growing illegal substances. The aim is to encourage allotment holders to maintain their plots in a tidy state. The Clerk was asked to circulate the revised Agreement to allotment holders with a request they submit any comments and suggestions by 15 November.

It was agreed that although the festival had been very successful and brought many people into the village the Council is not resourced for event management. The Council agreed that if a Scarecrow Festival were proposed in future, it would provide support as appropriate (eg website) and some financial assistance.
